5.03 Agenda: Regarding regularization of services of TEQIP-3's Contractual temporary Assistant Professor. (Agenda required to be put as per Govt. of Rajasthan order Annexure- A3)

**Description:** A total of 24 TEQIP-3's contractually employed temporary Assistant Professor are working in the college for whom a consolidated remuneration of Rs. 70,000/- pm is being paid by the NPIU (MHRD) for 3 years which will end in 1st week of January 2021. The Govt. has directed that possibilities and procedure for absorbing these faculties as regular faculties on termination of their contractual employment be explored.

Although, all these 24 faculties are professionally excellent, and it is desirable that their services be regularized on termination of the contract, the same cannot be done as the "reservation roster" has not been invoked during their selection

faculty Decision: TEQIP-III faculties may be recruited through an open proper procedure and invoking of reservation roster on culmination of their current contractual period.

5.04 Agenda: Regarding Disposal of Regular Assistant Professor Employed in Excess of the Sanction/required numbers. (Agenda required to be put as per Govt. of Rajasthan order)

Description: The college has a posted strength of 22 regular Assistant Professors against the sanctioned strength of 62 and actually required strength of 38. Therefore, the agenda subject issue is not relevant to us.

Agenda: Regarding Recruitment of Associate Professor & Professors (Agenda required to be put as per Govt. of Rajasthan order)

Description: There is only one Associate professor posted in the college against the sanctioned strength of 17, and against the actually required strength of 12. Therefore, 11 more Associate Professors are actually required. As far as Professors are concerned, there is only one Professor who is also the Principal. Therefore, effectively, there is no Professor in the college. The sanctioned strength is 7 and actually required strength is 6. Accordingly, 6 Professors are required. To sum up, there is an urgent requirement of 11 Associate Professors and 6 Professors to qualify the NBA accreditation.

There are two options for meeting the requirement of Associate Professor and professors as follows:

Option A:- Promoting all existing 11 Asst. Professor of 2007 batch to Associate Professors and filling the consequent 11 Asst. Professor vacancies, through guest faculties. This option is not recommended because these 11 Asst. Prof. do not meet the QR for promotion to Associate Professors, unless out-of-turn/relaxed QRS are adopted, which is not desirable in the larger interest of the college. Also, this option does not address the problem of Professors, and above all, because the college will be unable to take the additional financial burden.

Option B:- TEQIP-3 has provided us 24 Assistant Professor for 3 years through central recruitment and funding. It is recommended that NPIU recruits 11 Associate Professors and 6 Professors for us on 3 years contract basis and pays to them. These Associate professors/ Professors could be even retired personnel from state Colleges/Universities where the retirement age is 60 years, where as they can be employed till the age of 70 years as per AICTE eligibility. After 3 years the financial condition of the college will improve, it will get NBA accreditation and our own cadre will become eligible for promotion to Associate Professor. Therefore, this is the most viable option.

To conclude, option B is recommended.

**Option C:-** The Govt. of Rajasthan vide its letter no. 20(5)/T.E/04 part dated 01 May 2018 (Annexure A-5.1) has directed that approval from BoG be obtained for recruitment of required no. of Associate Professors (11) and Professors (6) through a centralized recruitment procedure. However this direction does not clarify as to who would pay this salary, this will cause unaffordable burden on the existing fragile financial structure/ college.

Despite the aforesaid it is proposed that option C be adopted, as directed by Govt, and additionally, option to the college administration be left open to engage, retired Associate Professors and Professors within the AICTE superannuation age on contract to lighten the financial burden as well as to meet the NBA accreditation requirement.

**Decision:** Option 'C' approved. GEC Bharatpur to send the requirement and details of 11 Associate Professors and 6 Professors along with the reservation roster to AD for centralized regular recruitment.

Agenda: Regarding implementation of CAS for regular faculties for upgradation of AGP from Rs. 6000/- to Rs. 7000/- and from Rs. 7000/- to Rs. 8000/-

**Description:** CAS for upgradation of AGP for Rs. 6000/- to Rs. 7000/- for regular faculties of Year 2007 batch was implemented in 2015-16 and a panel of experts for future CAS was approved in 4th BoG meeting. There is another requirement of holding CAS for AGP upgradation from Rs 6000 to Rs 7000 for faculties of year 2012 batch and some faculties of year 2007 batch. Also, there is a requirement for CAS for AGP upgradation from Rs. 7000/- to Rs. 8000/- for faculties of Year 2007 batch.

Govt. of Rajasthan, Dept of T.E. vide its letters 22¼7½r-f"k-@09&l dt. 01-01-2018 (Annexure -A6.1) and letter 22(7)T.E./08-l dt. 26-04-2018 (Annexure- A6.2) had created two ambiguities — firstly, whether CAS is to be implemented centrally under their arrangements, and secondly, CAS is to be implemented for only those faculties who are eligible upto 31-12-2015. Both these ambiguities are well answered by AICTE gazette, (Annexure-A6.3) that CAS is to be implemented under supervision of BoG and that CAS is to be given to each eligible faculty, but the same has now been clarified in favor of this AICTE gazette vide Govt's letter no. 20(5)T.E/04 part dated 01 May 2018 (Annexure-A5.1) Also, this college is financially capable of granting CAS to all of its eligible faculties in terms of AGP upgradation.

5.07 **Agenda:** Regarding Recruitment of Non-Teaching Staff. (Agenda required to be put as per Govt. of Rajasthan order)

Description: The College has a total sanctioned as well as filled strength of 76 non-Teaching staff. All non-teaching staff are contracted through a service provider agency, i.e. none of the 76 staff is regular. Therefore, all 76 non-teaching posts are vacant and all 76 posts are actually required by the College. However, the college does not have the financial capacity to pay them the scales of regular staff (7th pay commission salary, or even 6th pay commission salary). However, the college will save about Rs. 5 Lacs per month after relieving the 24 guest faculties, and this fund can be made available for recruitment of some (not all 76) non-teaching staff. It is desirable that those non-teaching staff posts be filled first where either the Faculties are engaged (such as Dy. Registrar/ Asst. Registrar, Accounts Officer, Asst. Librarian etc) so that the faculties are relieved for doing their original job or where accountability of the post is of paramount importance. Summarily, 2 criteria are selected for identifying 11 posts (or 13 persons) out of 76 post for recruitment — firstly, these posts must either relieve incumbent faculties, or be necessitated by accountability, and secondly, the total salary per month to be paid should be affordable, i.e. about Rs. 5 Lacs.

The list of these 11 posts (total 14 personnel) along with their eligibility and approximate salary is attached at Annexure A7.1 The recommended eligibility and salary structure of these posts are already approved for EC Bikaner which was advertised by them, and same is attached **Annexure-A7.2** 

It is recommended that the identified posts be recruited urgently through any third agency under the supervision of the BoG and the Govt. after taking due permission from the Govt if required.

Decision: following decisions were taken:-

- a) The total no. of posts be increased from 11 to 12 and total no. of personnel be increased from 14 to 16. The additional post is that of the driver and the additional personnel are 2 drivers. Annexure 7.1 of the agenda of the 5<sup>th</sup> BoG be amended accordingly.

Numerous steps/ correspondences have been taken in this regard to resolve the issue, but the stalemate continues. Therefore, there is an urgent need to resolve the issue. The college constituted a study-team for recommending the course-of-action for resolution of the problem. The report of the study-team is placed separately in a booklet form at Encl-2 for perusal. This report has been submitted to T.E. Dept. through the Hon'ble President GEC Bharatpur Society.

#### **Description:**

The Govt. of Rajasthan, Technical Education Department, has promulgated its policy for Higher Study leave (in our context for PhD) vide its letter no. F.no. 4(7)T.E./2001 part of 2015 (Annexure-A12.1) with an amplification/ clarification given vide its letter no. 4(7)T.E./2001 part dated 26 Oct. 2015 (Annexure-A12.2)

Until now, the college has not sent any faculty for PhD on study leave as per this policy, due to two basic reasons — firstly, paucity of faculties, and secondly, paucity of funds. Now, with TEQIP-III having been enforced, both constraints have relaxed. Therefore, there is a need of non-PhD faculties to be sent on study leave to acquire higher degrees for empowering the college to get NBA accreditation. The list of faculties (a) having done PhD, (b) doing PhD and (c) not done PhD, but required to do PhD is attached at Annexure A12.3. There are a total of 12 faculties who require to do PhD, for whom, a uniform policy is required to be devised for detailment.

It is proposed that the aforesaid extant policy of Govt. of Rajasthan (Annexure A12.1 & A12.2) be adopted with the following changed adaptation which are necessitated by our typical institution requirements:-

- (A) The existing maximum 10% of faculties being on study leave at any time be relaxed to maximum no. of faculties being on PhD to 6 faculties. This is because all 12 faculties have to do PhD within remaining period of TEQIP-III to get its full advantage.
- (B) The steps no. C, D & E of paragraph 5 named "Procedure for Selection" of Annexure A12.1 be relaxed to make the process speedy and also to customize is to the college's requirement. In that, it is proposed that "upon the recommendation of the scrutiny committee, the Principal shall finalize the list and get it approved on file from the President, GEC Bharatpur Society by 15 May of each year.

5.13 Agenda: Shifting of GEC Bharatpur Hostel.

> Description: GEC Bharatpur is running boys and girls hostel after taking proper permission from the authorities, as already described in the minutes of the 3rd and 4th BoG. Presently, the Girls Hostel is being run in a hired building in the city. The boys Hostel is partly being run in a hired building in the city (about 70 boys of 2nd year) and partly run form within the campus in two buildings – ME lab (about 30 boys of 1st year) and CE lab (about 30 boys of 1st year). The Campus hostel, was housed in these building after taking proper permission because these building were unutilized since no lab equipments were held, and because there was (and is) a severe requirement for hostels. Now equipment are being procured through TEQIP-3. Therefore, these two buildings are to be vacated and the in-campus hostel boys are to be shifted in the hostel hired out-side the campus. Additional rooms will be required in the hired building to accommodate these boys, as well as for boys to be admitted freshly.

It is proposed that permission be granted to shift the boys from the in-campus building to out-of campus hired building by hiring additional rooms in that building for these boys as well as for boys to be admitted freshly.

#### Agenda: Upgradation of 10 mbps to 100 mbps connectivity 5.15

Description: An OFC based 10 mbps system is working between BSNL PoP & the college to provide internet connectivity. As per AICTE requirement, and as per RTU's observation during inspection, the college must upgrade the system to 100 mbps connectivity. Efforts were made to get the same through TEQIP-3 funds, but the same has been declined by NPIU. The cost (rent) being paid by the college to BSNL to the existing 10 mbps system is approximately Rs. 389400 per annum. The cost (rent) for the 100 mbps system will be approximately Rs 2065000 per annum.
